PUBLIC ISSUES FOR PARISH BULLETINS JANUARY 2016

The state of housing is pivotal for health and the cost of housing is a key driver of poverty. A Warrant of Fitness was introduced to bring State Houses up to health standards - with insulation and fire alarms as key issues for health and safety. At present there is a bill to introduce insulation and safety measures in all rental properties. This is important as 50% of New Zealanders live in rented houses and many do not meet standards of warmth and health safeguards. Public Issues is preparing a submission and welcomes any comments from church people. The main concern with the bill is that the standards for insulation are too low. PRAYER NEEDS

ANNUAL HOLIDAY - I will be away from the parish for my Annual Holiday from the 11th of January to the 2nd of February 2016. While I am away Rev Rod Mitchell will take care of the pastoral matters of the parish. Rev Gordon Abernethy has offered to help also in the pastoral matters of the parish when Rod is away.

PARISH YOUTH MINISTRY - I am planning to run a Youth Ministry Workshop in the parish this year. The purpose of this workshop is to inspire and facilitate the young adults of the parish to maintain their connection with the parish and to participate in the ongoing ministry of the parish. I have approached the Tauiwi National Co-ordinator for Children, Youth, and Family Ministries, Michael Lemanu and he is interested in co-ordinating such an event. I urge the parents, young people, and those who have passion for youth ministry to support this initiative as our vision for the future of 'Let the Children Live.' **FUTURE OF MY MINISTRY** - While I am away on my Annual Holiday, the Synod needs to know the future of my ministry in the parish. It means that congregations in the parish need to start talking about my involvement in the future of the parish. A formal parish meeting will be held later to formalise a decision but it is necessary to start the conversation as soon as possible.

STORY FROM THE MISSION

Client Support: I was approached by an MPs office with a referral for a person who needed some guidance to move forward after experiencing a serious assault which left them



incapacitated and unable to work. I was asked to see this person and as always asked the MPs office to pass my name and phone number on to the person, it must be their choice to engage.

I received a phone call almost immediately! Our initial assessment was one of collecting information around the traumatic incident, how this has affected their life, physically, emotionally, what changes they have made in regard to their personal safety and the impact this incident has had on the relationship with their family; they have also been recently widowed. Not being able to return to work because of the injuries sustained in the beating has created social isolation and they felt noone was listening to them.

We created a plan identifying the most important issues for the client – "Safety" - to know what investigation was taking place, where were they at (as they had not heard anything from the police and felt extremely unsafe in their own home) with practical steps to keep safe such as locking doors when hanging out washing or going to the mailbox, and to reduce the fearfulness and often inability to leave the home unsupported. ACC of course were involved, but no other agency.

This plan was devised by the client.

- ACC will fund Driving Miss Daisy, creating independence until they are allowed to drive again needs medical clearance.
- Needs to look at new accommodation and move in before Christmas. Who will help with this?
- Use own research methods/internet to look at accommodation options.
- Follow up on Police report. Will follow complaints procedure if necessary.
- Circle of friends utilize all as resources to minimize social isolation, with random phone calls. Out for Coffee/Drinks/Social gatherings.
- Family meetings discussions, make a list of wants and needs and supports - identify who will do what by when.
- Attend Medical appointments using Driving Miss Daisy or family/friends for transport.
- Safety Plan in the house family members to phone in each evening/morning to check.

I would not have been able to come up with a better plan. This client is resilient and is able to articulate their needs and wants, but did not know how to go about this; my role was to unclutter the events and help identify their needs into some format that did not appear as an imposition to others.

This client has engaged with their friends again; has followed up on investigation, used their computer to research accommodation options and arrange house viewings, and the relationship with the family is now back on track.


