Waihōpai Youth Transition House



Celeste who was ready to transition out of the YTH. Celeste had found herself employment during her time here, and own accommodation. She had done all the right things, however, was stuck in limbo with getting assistance for a bond. Because Celeste had started working, Youth Services was unable to assist and help her, and because she was under the age of 18 Work and Income were unable to help. Celeste was very anxious that she was going to lose the place she thought she had secured, so Tammylee jumped on the phone to my contact at MSD.

We talked through ways that MSD could help. It was a very grey area, and Tammylee's contact was unsure if they could help in any way. MSD ended up getting in contact with the landlord, as well as our resident. MSD got Celeste's income details, work information, as well as any

information that she could, to help get Celeste's application across the line, even though she was not an MSD client.

In the end after a lot of back and forth with the landlord and resident, the MSD staff member got the bond approved, and Celeste in that week and is doing very well with sustaining her tenancy.
